In 1968, Paul R. Ehrlich: The battle to feed humanity had been lost and that there would be <u>a major food shortage in the US. "In the 1970s ... hundreds of millions are going to starve to death</u>,"

He forecast that <u>65 million Americans would die of starvation between 1980-1989</u>, and that by 1999, the US population would decline to 22.6 million.

Ehrlich: "I have yet to meet anyone familiar with the situation who thinks India will be self-sufficient in food by 1971, if ever."

Data: Yet in only a few years India was exporting food and significantly changed its food production capacity.






The 2003 Heat Wave was blamed for 2000 deaths.

Sir David King, the Government's Chief Scientific Officer, later said that Climate Change was "more dangerous than terrorism." in terms of lives that could be lost

Such language is never used about the cold, which kills at least 10 times as many people every winter.

Since Sir David's exhortations, 250,000 Brits have died from the cold, and 10,000 from the heat.

The data show that it is Cold Temperatures which cause the highest human death rates; Warmer Temperatures have lower death rates.



Who says that a little warming is a threat of serious damage?

Warming and addition of CO2 are beneficial to the environment and to the plants upon which all animal life depends for sustenance.

More CO2 in the air makes almost all plant life more productive in leaves, stems stalks, roots, fruits and seeds. CO2 is plant fertilizer, a grade school lesson.

Frost and Ice are fatal to many/most food crops.

Many more people die from freezing in the cold than die from the heat.

In 1992, countries joined an international treaty, the United Nations Framework Convention on Climate Change, to cooperatively consider what they could do to limit average global temperature increases and the resulting climate change, and to cope with whatever impacts were, by then, inevitable.






ABC News and NASA, in the graphic above, attempt to show that Carbon Dioxide is the most important Greenhouse Gas, which they abbreviate GHG.


NASA satellites show measured global temperatures <u>in the greenhouse</u>.




- Graphic example of a proxy for temperature using O16/O18 ratio in snow which fell near the highest point on the Greenland Ice Sheet.

- Annual rings determine the date of the ice; O16/O18 determines temperature








Global Land-Ocean Temperature Index







Figure 1. Temperature history from a crucial portion of the atmosphere, 1958–1995. For some reason, in the important paper "demonstrating" climate change, Ben Santer and colleagues only used the portion of the data circled here.








PCM Simulations of Zonal-Mean Atmospheric Temperature Change










Pink fuzz represents stated uncertainty.



See for yourself: as the period gets shorter, rate of rise of temperature increases.




Now, "the Rest of the Story"




Please note that this is the statement of someone who by and large supports global warming alarm.










Figure 1. Temperature history from a crucial portion of the atmosphere, 1958–1995. For some reason, in the important paper "demonstrating" climate change, Ben Santer and colleagues only used the portion of the data circled here.

Today, few academics are even aware of what the pioneers understood, let alone what has been learned since about the full depth of modeling difficulties.


Meanwhile popular expressions of the scientific technicalities are largely superficial, defective, comically nonsensical, and virtually uncorrectable.


Sherwood et al, 2008, Robust Tropospheric Warming Revealed by Iteratively Homogenized Radiosonde Data





Science, Math, Computer Science, and Engineering Graduates, 2010 (proportion of all graduates in 2010)




Galileo: Why he matters today


Galileo's championing of <u>heliocentrism</u> was controversial within his lifetime, when most subscribed to <u>geocentrism</u>.

The <u>Roman Inquisition</u> in 1615, concluded that heliocentrism was false and contrary to <u>scripture</u>, placing works advocating the Copernican system on the <u>index of banned books</u> and forbidding Galileo from advocating heliocentrism.^{[9][10]}


He was tried by the <u>Holy Office</u>, then found "vehemently suspect of <u>heresy</u>", was forced to recant, and spent the last nine years of his life under house arrest.
