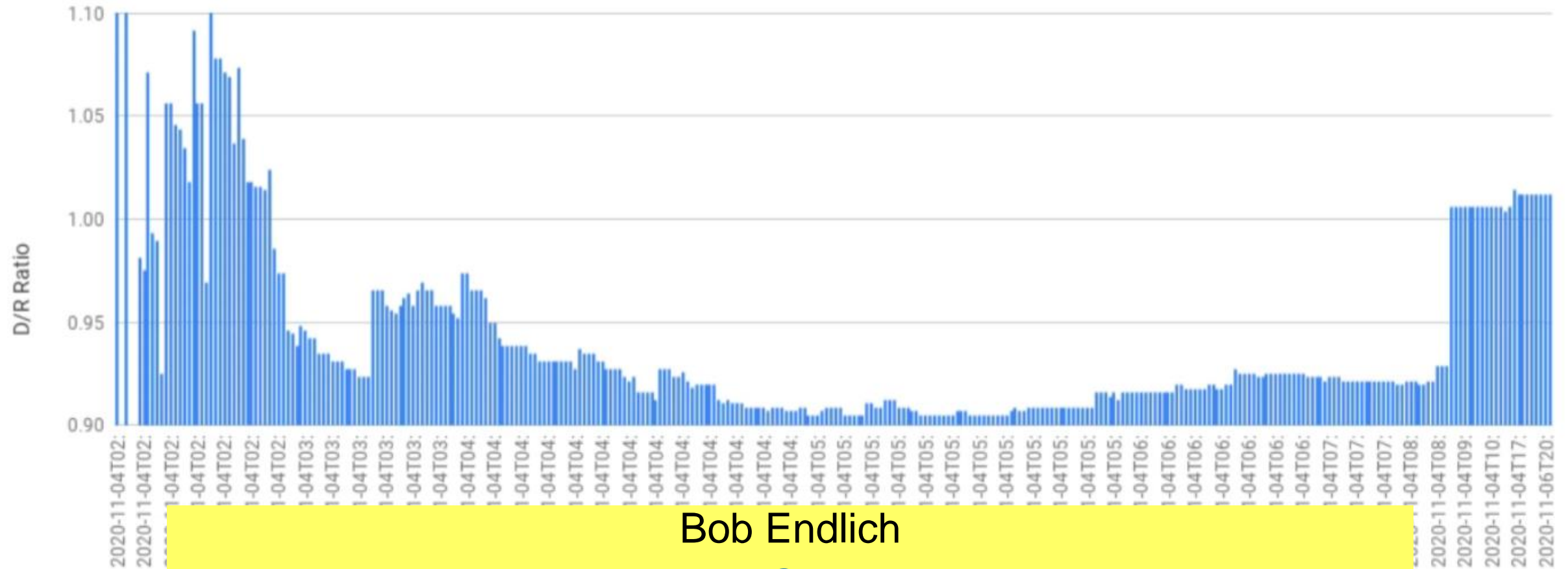

Authorities in Arizona are investigating after more than a dozen ballots were stolen from mailboxes and discovered last week at a farm.



...At one point the New York Times's "meter" had Trump's chances in North Carolina at 92%. The needle was also sliding in the president's direction in Arizona and Georgia, among others.

And then, suddenly, the counting stopped in at least five states (or parts of states): Georgia, Michigan, Nevada, North Carolina, Pennsylvania, and Wisconsin; all but one with a Democratic governor (coincidence, surely!).

When has that ever happened?

Well, it happened in Broward County, Florida, in 2018, when a dodgy Democratic election official appeared to be intervening, illicitly, on her party's behalf. The process only got back underway when the state's (Republican) governor intervened and had her removed from the process. *(Bolding, Paragraphing, added)*

But getting back to last night, some time in the wee hours, additional ballots were “found” and added to early totals which had Trump ahead. To no one’s surprise, those votes were overwhelmingly—literally as much as 100% in some batches—for Biden. According to Nate Silver, no one’s idea of a Trumpist, one tranche of 23,277 votes that turned up in Philadelphia were “all for Biden.” Absent some kind of harvesting or fraud (or both), that’s a logical and statistical impossibility.

Through the night, all such ballots came from heavily Democratic areas posting unusually, improbably high turnout. 85% in Milwaukee?

A city that turned out at only 61% in 2016, and even with Obama on the ballot in 2012, at 71%? But 85% for Sleepy Joe? According to one report, seven Milwaukee precincts returned more presidential votes than they have registered voters.

Turnout in Wisconsin overall is alleged to have been 89.25%, more than five standard deviations for the state’s mean turnout since 1960—another statistical impossibility.

One might also wonder why this urban Blue wave materialized only in close states. Milwaukee was way up but not Cleveland? Philly but not St. Louis? Granted Ohio and Missouri are Red, but their big cities aren't.

How It's Done

We've seen this movie before.

This is how they beat Scott Walker in Wisconsin in 2018, Tom Foley in Connecticut in 2010, and Norm Coleman in Minnesota in 2008.

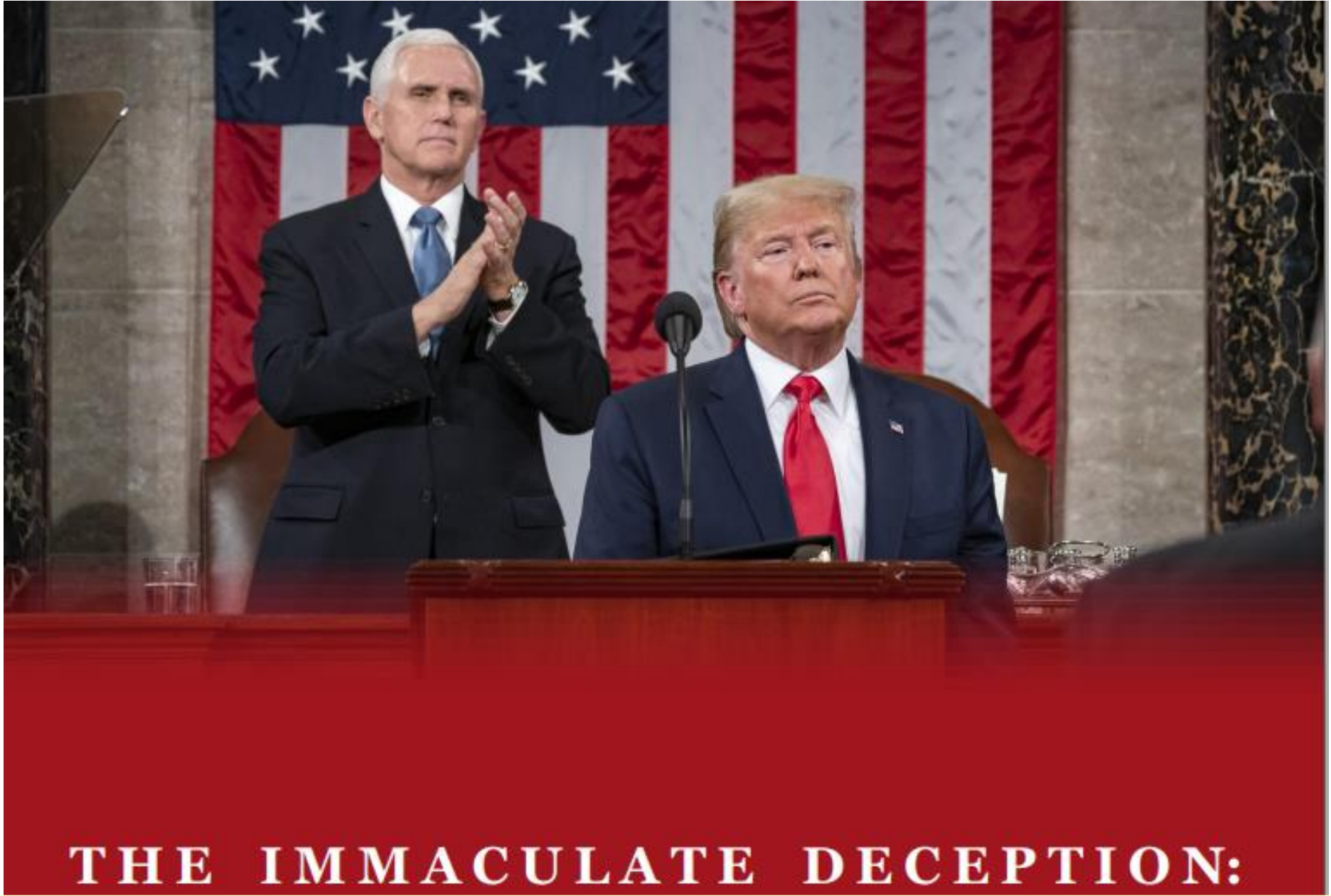
Why stop the count? Because that's the only way to know how many votes you need to "win."

Sure, you can just brute force things by backing up a truck full of ballots. But that looks bad. You might even end up counting more votes than there are registered voters in the state. Better to eke out a narrow win. As Joseph Kennedy, Sr. allegedly said to his second son, *"I'm not paying for a landslide."*

We see when the counting resumed, directly in the data, the chunks of votes added with the overwhelming Biden pluralities. **The four vote updates which show this distinct pattern follow:**

3. A vote update in Georgia listed at 1:34AM Eastern Time on November 4th, 2020, which shows 136,155 votes for Joe Biden and 29,115 votes for Donald Trump
4. An update in Michigan listed as of 3:50AM Eastern Time on November 4th, 2020, which shows 54,497 votes for Joe Biden and 4,718 votes for Donald Trump.

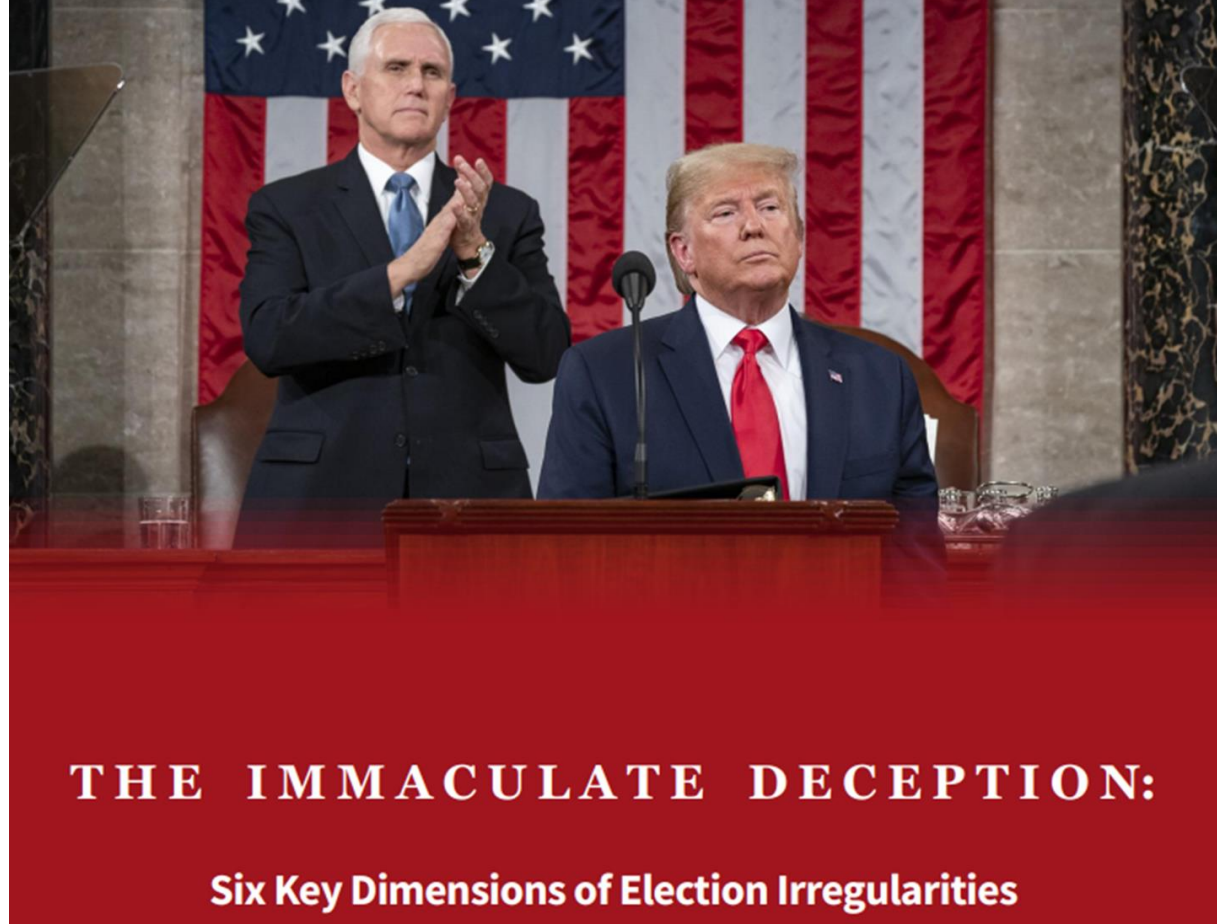

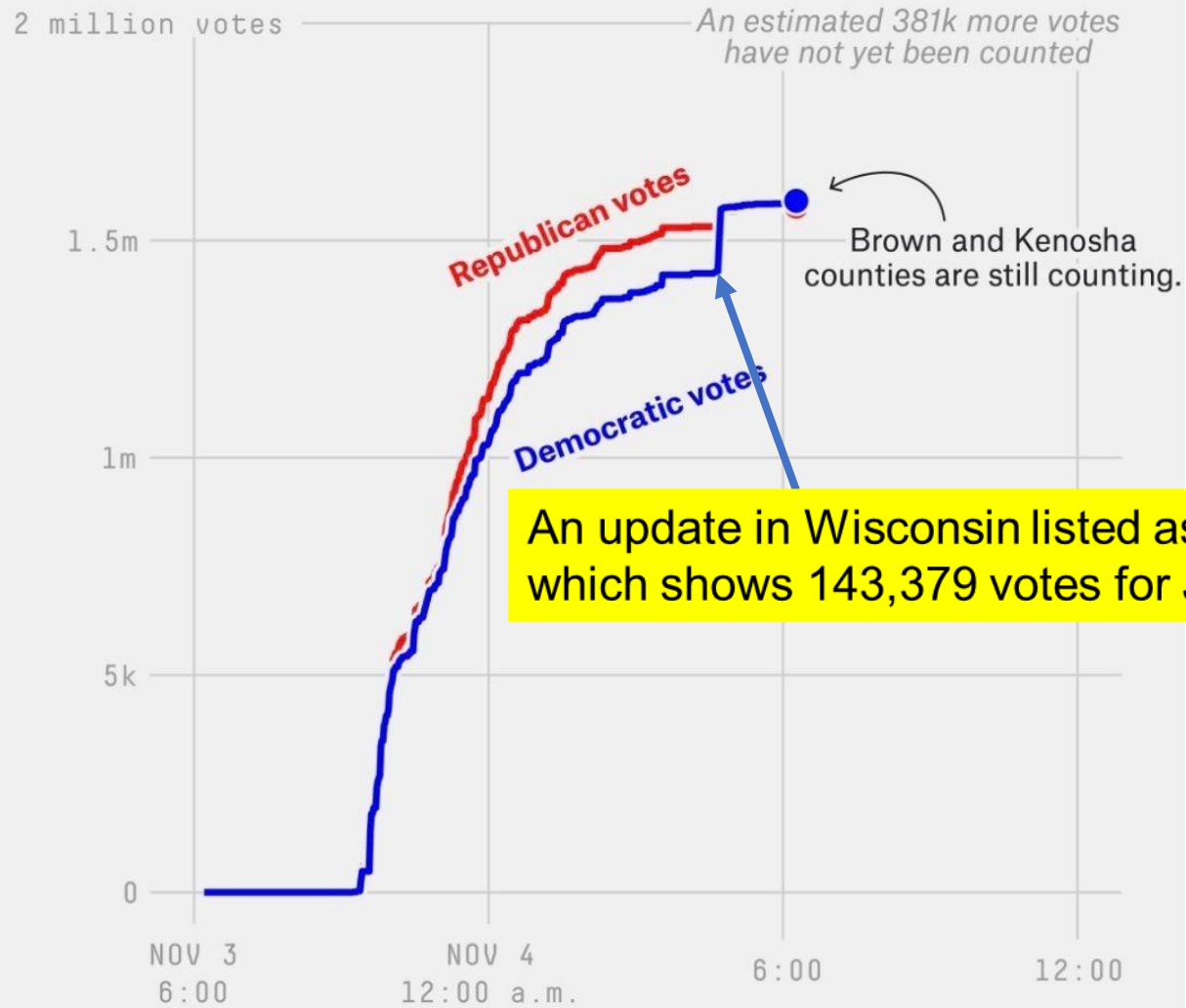

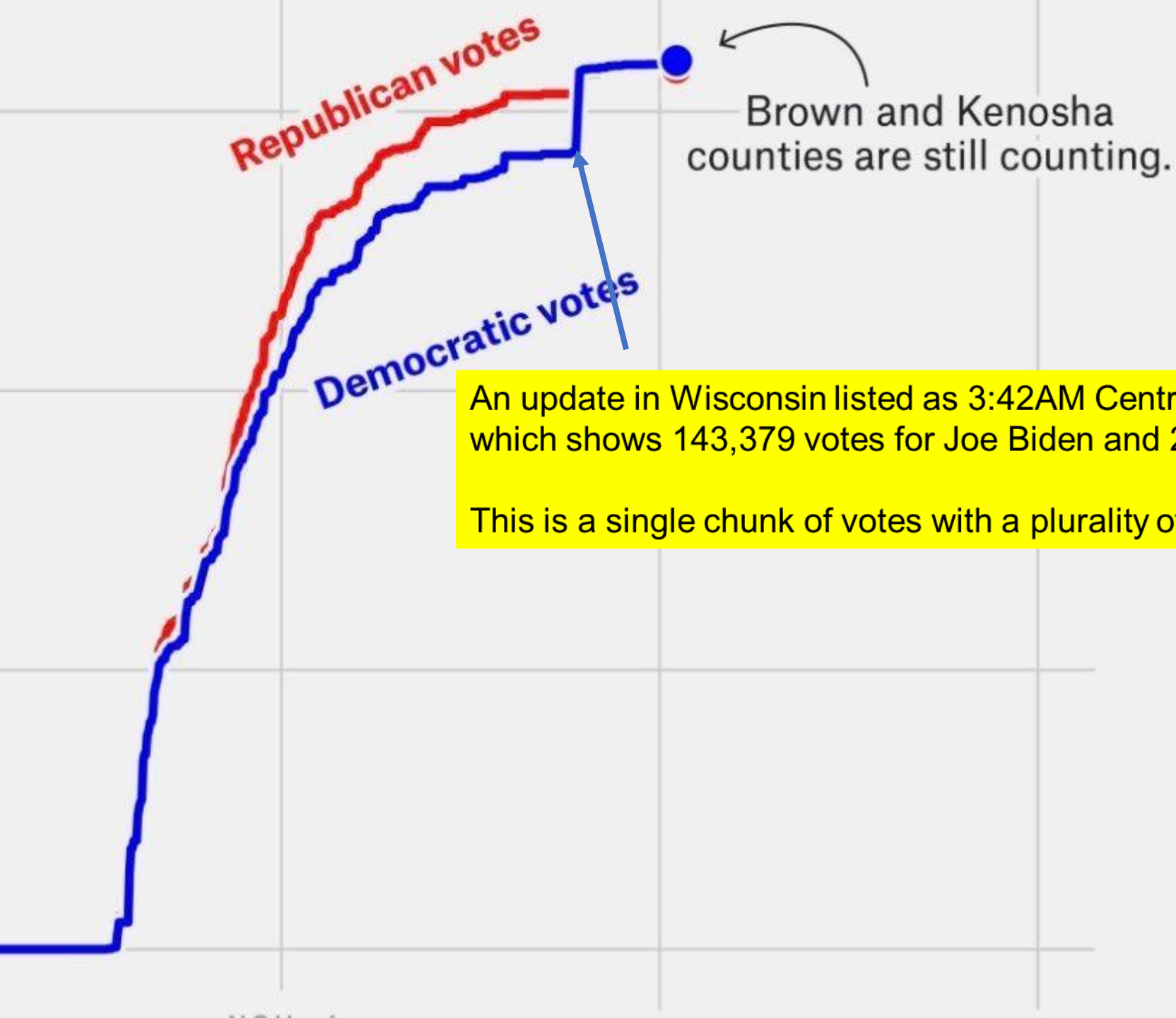
The state of the race in Wisconsin

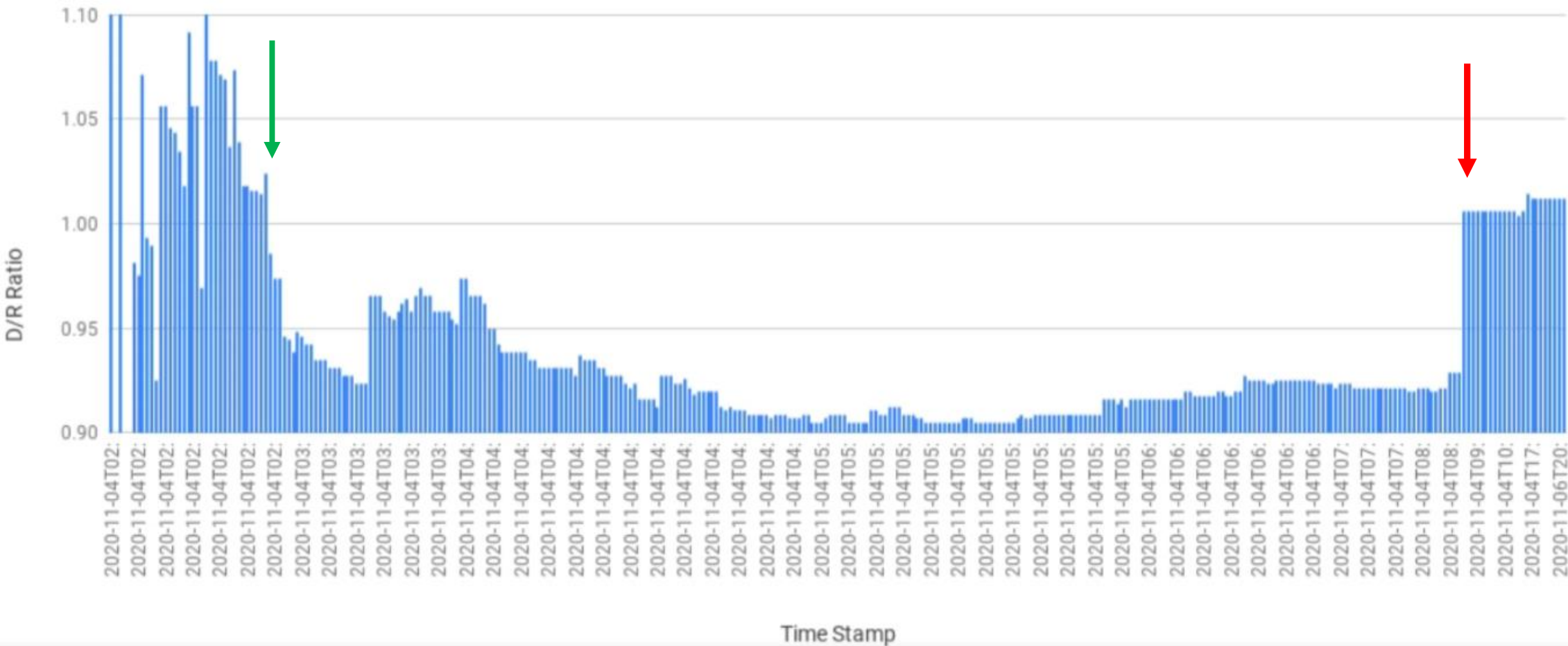

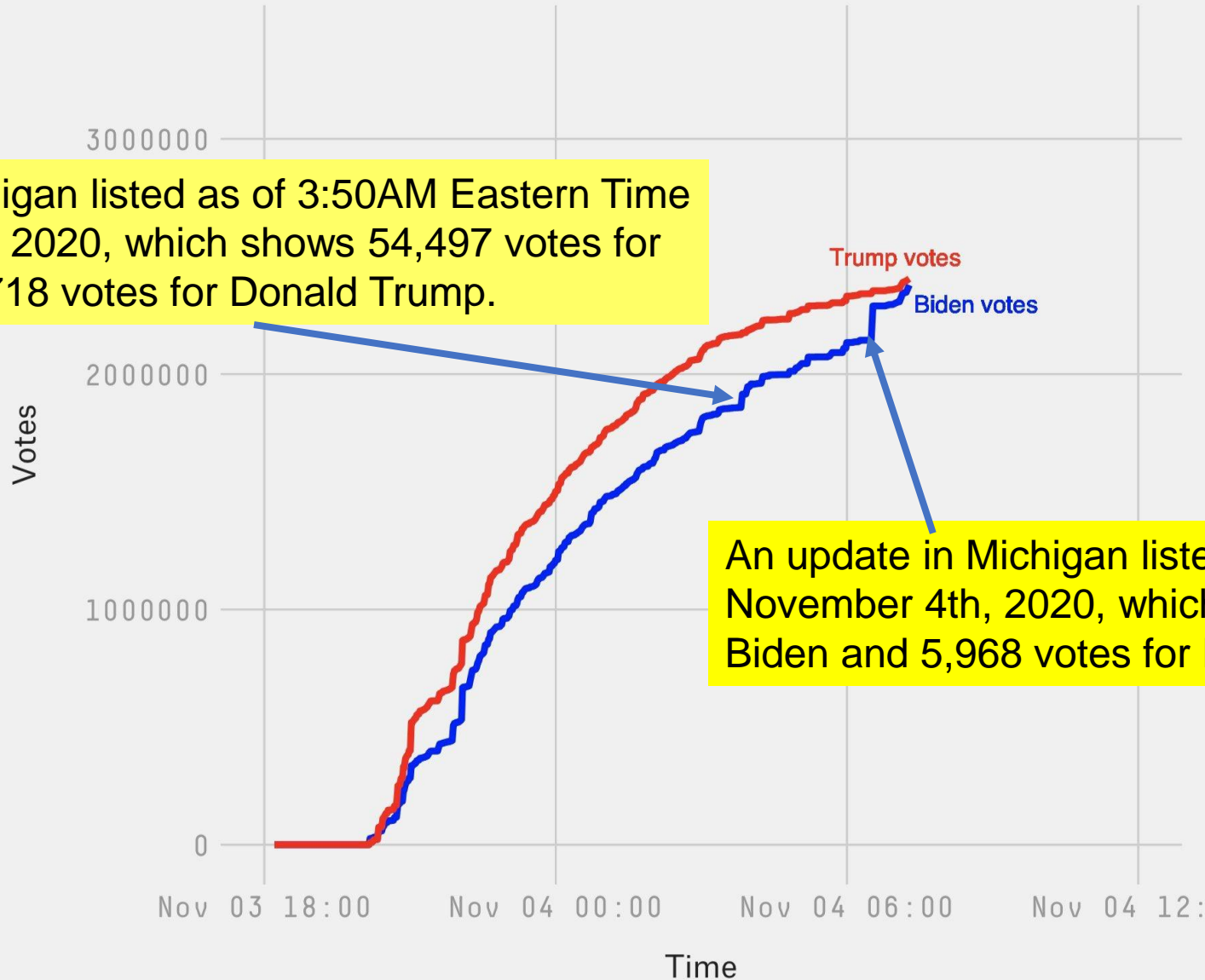
Wisconsin Democrat/Republican Vote Ratio Vs. Time

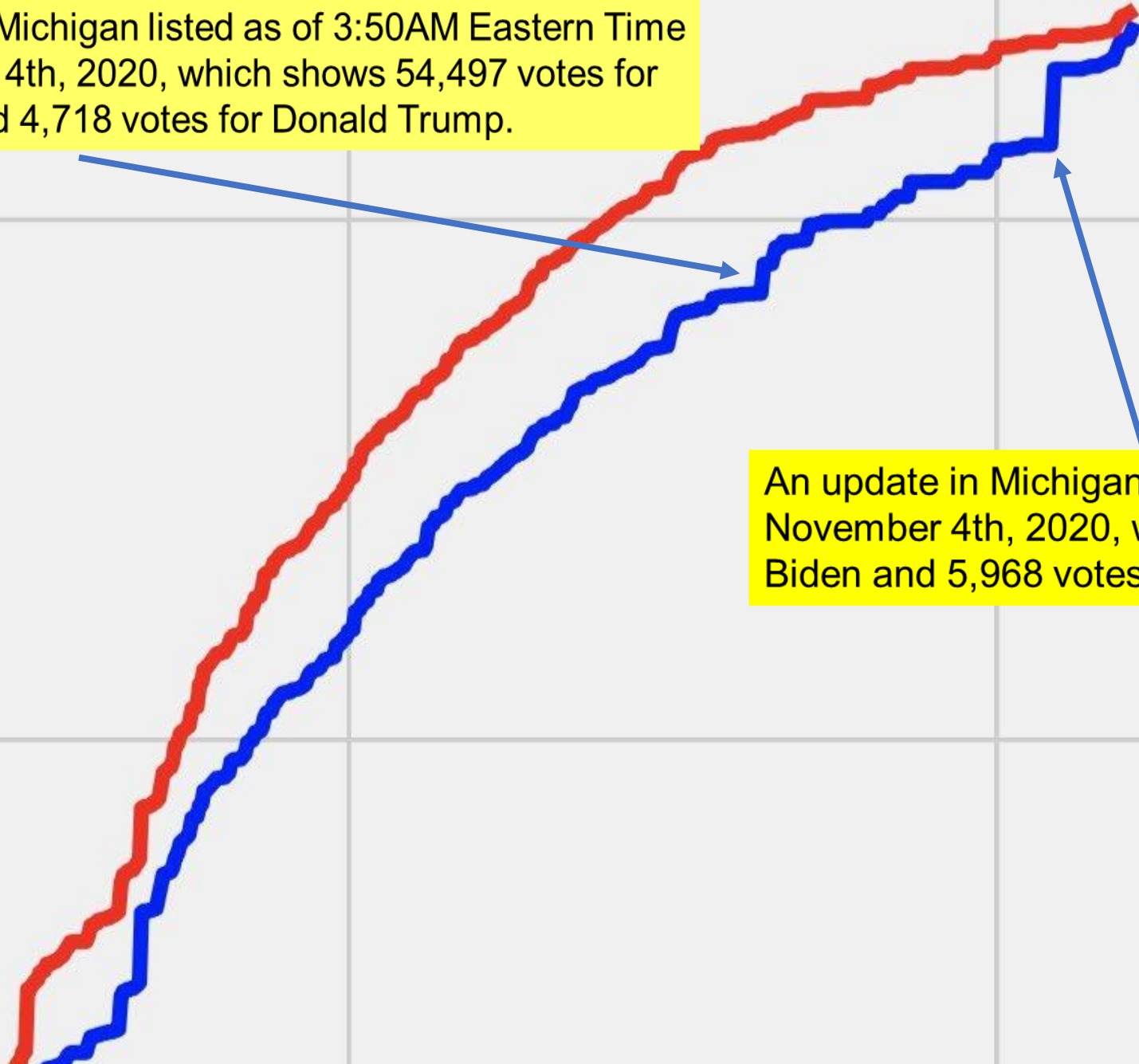

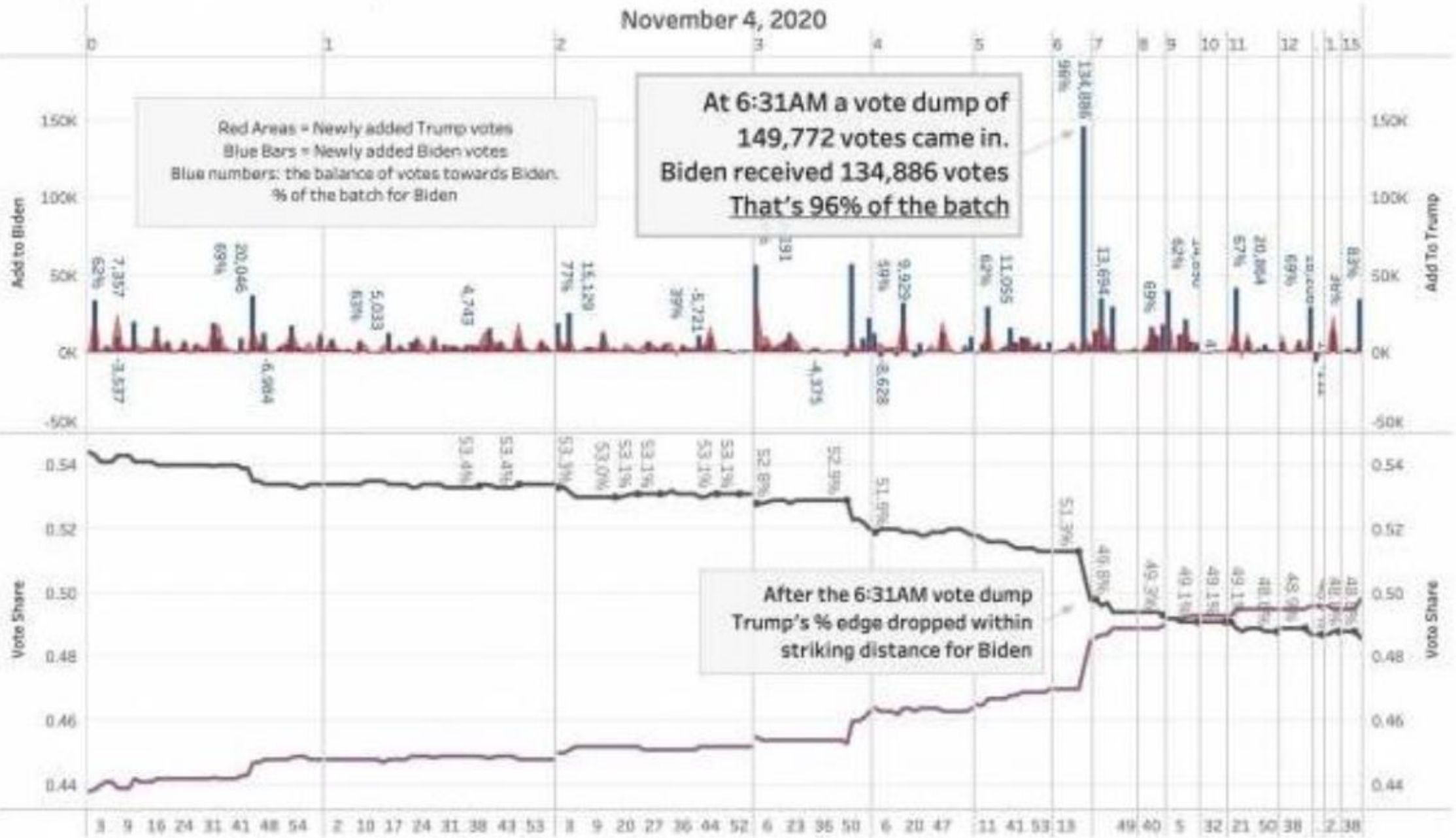

Crucial Logs Missing From Antrim County Dominion Voting Machines: Forensics Report

Crucial security and adjudication logs are missing from Dominion Voting Systems machines from Michigan's Antrim County, according to a forensics report released on Dec. 14 in compliance with a court order.

“Significantly, the computer system shows vote adjudication logs for prior years; but all adjudication log entries for the 2020 election cycle are missing. The adjudication process is the simplest way to manually manipulate votes. The lack of records prevents any form of audit accountability, and their conspicuous absence is extremely suspicious since the files exist for previous years using the same software,” the report, authored by Russell Ramsland, states.

Dozens of witnesses claimed that they observed **deliveries of ballots in the middle of the night after ballot arrivals were supposed to end, people bubbling blank ballots in for Democrats, duplicate ballots being misplaced or wrongfully placed under boxes, all while poll challengers were forced to stand so far away from tables that they could not see the tabulation screens.**

Democratic Operative Goes Into Detail About How He Rigged Elections

With the Wuhan coronavirus pandemic still raging on, most states are looking at some sort of mail-in voting for the November General Election. In fact, some states won't even offer in-person voting. It will be entirely conducted by mail. President Donald Trump has repeatedly called into question just how secure mail-in voting really is and the potential for fraud.

In fact, a reporter in Pennsylvania conducted a mock election to see how many ballots would be returned once they were mailed from different parts of Philadelphia. The USPS lost three percent of the ballots. Back in May the Department of Justice pressed charges on a mail carrier for altering mail-in ballot request forms. And who could forget: the primary elections in New York's 12th and 15th Congressional Districts took more than six weeks to count because election officials were unprepared for a massive increase in absentee ballots.

Despite what we know, there's still a debate over whether or not vote fraud is an issue... until now.

A Democratic political operative in New Jersey admitted to the New York Post that for decades he changed votes in a number of local legislative, mayoral and congressional races across the state. In particular, the operative noted that he changed votes in elections in Paterson, Atlantic City, Camden, Newark, Hoboken and Hudson County.

“An election that is swayed by 500 votes, 1,000 votes — it can make a difference,” the operative told the Post. “It could be enough to flip states.”

Not only did this man change votes himself but he led teams of people who did the same thing. He even trained 20 operatives in New York and New Jersey as well as one of 2020's major swing states, Pennsylvania.

“There is no race in New Jersey — form City Council to United States Senate — that we haven’t worked on,” the operative explained. “I worked on a fire commissioner’s race in Burlington County. The smaller the race the easier it is to do.”

The fraudster said in some elections he made phony ballots because there were no watermarks or stamps used for security.

“I just put [the ballot] through the copy machine and it comes out the same way,” he explained.

But mail carriers are also in on this.

“You have a **postman** who is a rabid anti-Trump guy and he’s working in Bedminster or some Republican stronghold ... **He can take those [filled-out] ballots, and knowing 95% are going to a Republican, he can just throw those in the garbage,**” he explained.

Some carriers would even grab ballots and hand them over to the operative so they could be used fraudulently. Nursing home facilities were another area where the operative cashed in on votes.

“There are nursing homes where the nurse is actually a paid operative. And they go room by room by room to these old people who still want to feel like they’re relevant,” he told the Post “[They] literally fill it out for them.”

And then there were times when members of the operative's crew would show up to polling locations in states like **New Jersey and New York, where ID is not required to vote.** They crew member would be given the name of a registered voter who routinely missed presidential and municipal elections, information that is available to the public. **The crew member would then vote as that person.**

“You fill out these index cards with that person’s name and district and you go around the city and say, ‘You’re going to be him, you’re going to be him,’” he recalled.

All the fraudster had to do was fake the signature as best as he or she could.

Even the local board of election offices are rigged. While both parties argue over which ballots should be thrown out because of irregularities, the fraudster's team had an upper hand. **If they saw a bent corner on an envelope, they would let the ballot go through, knowing it was done by the operative and his team.**

“It doesn’t stay bent, but you can tell it’s been bent. Until the [certificate] is approved, the ballot doesn’t matter. They don’t get to see the ballot unless they approve the [certificate],” he explained. “I invented bending corners.”

When a ballot makes it past that point, the rest is history.

"Once a ballot is opened, it’s an anonymous ballot," he explained.

There's your proof, folks. Right from the horse's mouth. But the mainstream media will still tell us we're wearing our tinfoil hats and being paranoid.

Georgia Recount Witnesses Saw Trump Votes Counted for Biden

Affiants also swore to have seen suspiciously pristine, uncreased mail ballots, uniformly and perfectly filled out

Witnesses of the recount of the presidential election in Georgia have signed sworn statements testifying to having observed ballots cast for President Donald Trump being counted as though they were cast for former Vice President Joe Biden.

Trump campaign attorney Lin Wood filed the affidavits with a federal court in Georgia on Nov. 17 as part of an emergency motion seeking to block the certification of the election results in the Peach State.

Nine of the affiants swore to have seen suspiciously pristine, uncreased mail ballots, uniformly and perfectly filled out, almost always for Biden. In one case, a batch of such ballots included 500 ballots in a row all cast for Biden, the Democratic presidential nominee.

The lack of creases is strange considering that mail ballots have to be folded to fit in an envelope. Some of the witnesses said the perfect markings, all in black and never outside the voting bubble, appeared as though they were printed by a machine or stamped.

The emergency motion detailed these and other abnormalities, violations, and potential signs of voter fraud on the night prior to the deadline for Georgia's recount, which has already discovered, in three counties, batches of uncounted votes for Trump.

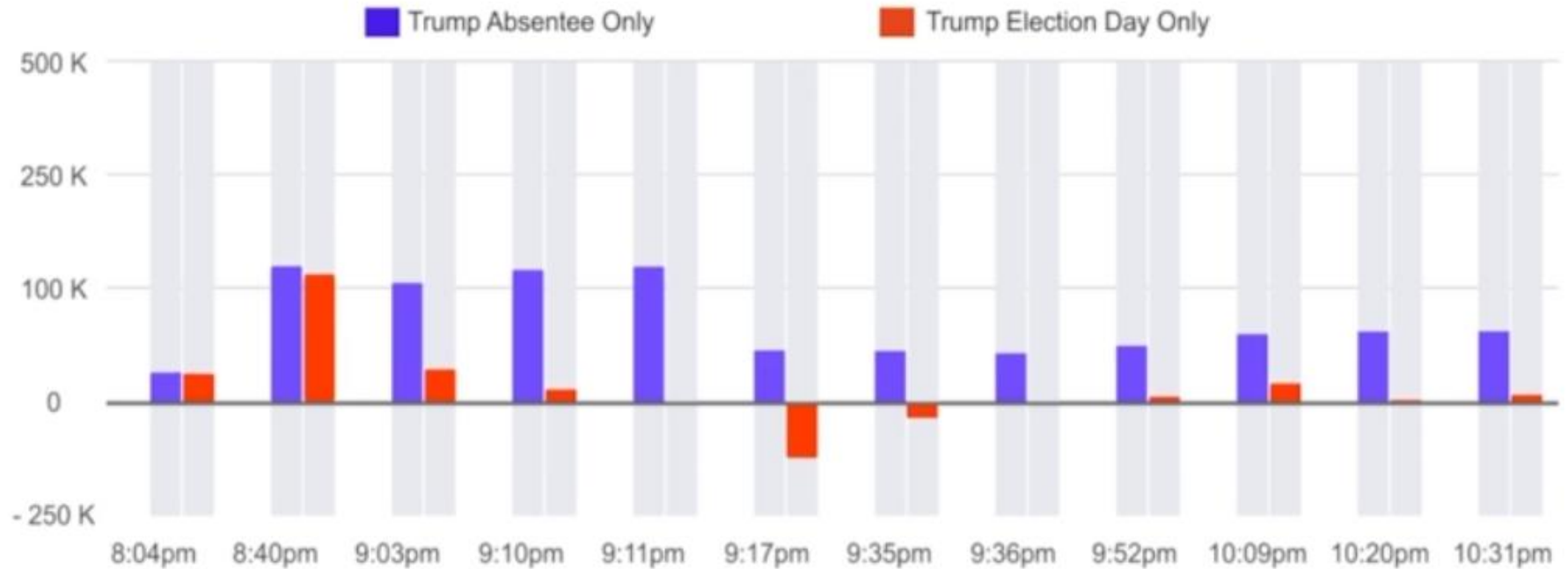

VOTE TOTALS FOR PRESIDENT TRUMP

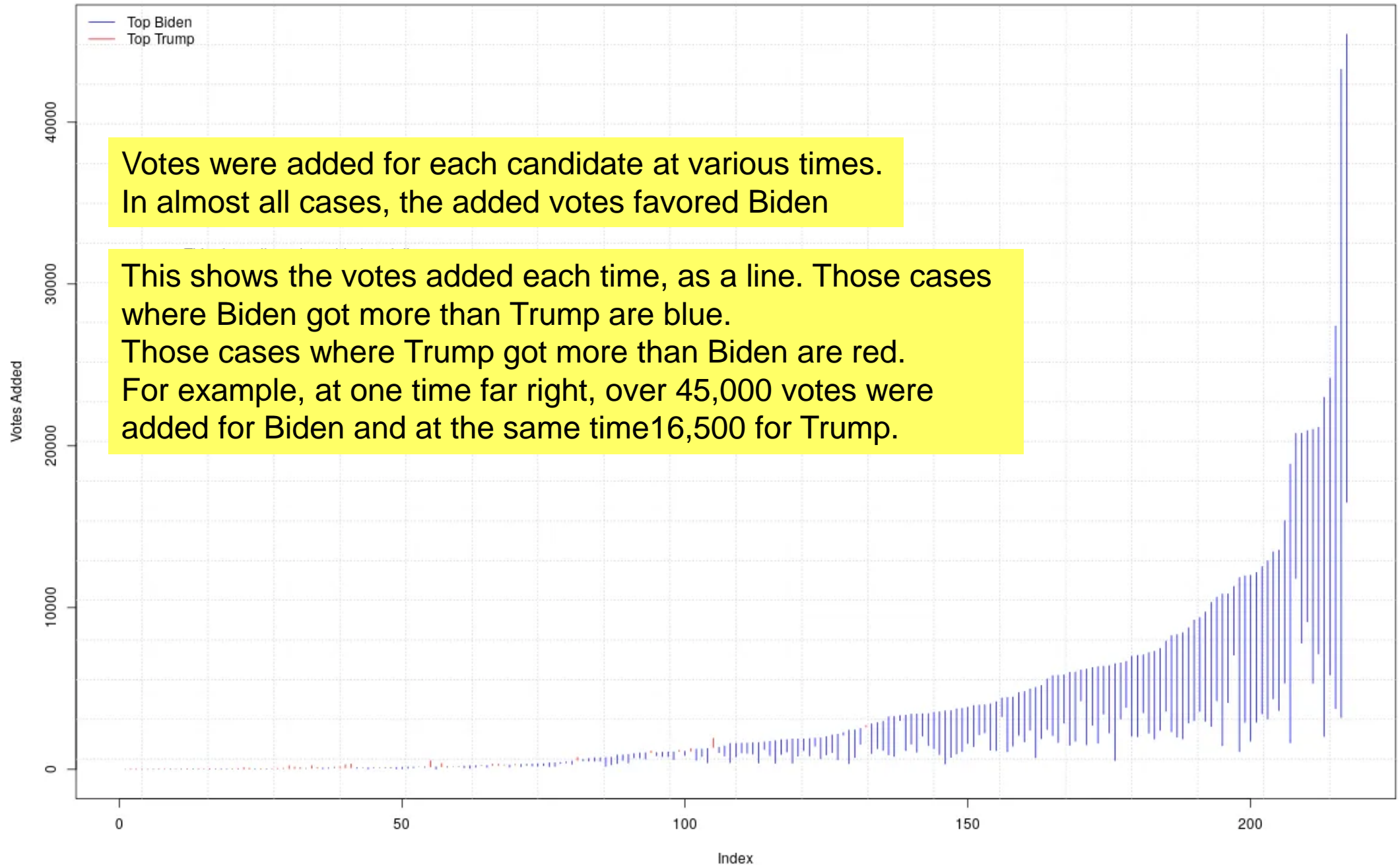

In Pennsylvania, the Red bars below the 0 line show Election Day votes TAKEN FROM TRUMP

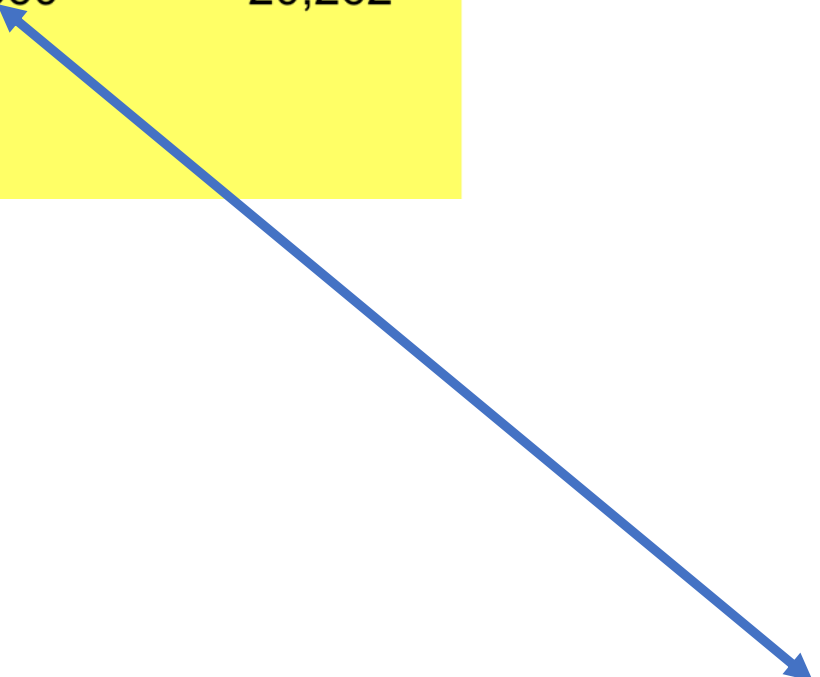
